AN ORDINANCE

AMENDING FILE OF THE COUNCIL NO. 112, 2003, ENTITLED "ESTABLISHING A UNIFORM RATE FOR PARKING METERS IN THE CITY OF SCRANTON AND THEREBY AMENDING FILE OF THE COUNCIL NO. 78, 1994 TO ESTABLISH THE UNIFORM RATE OF \$.50 AN HOUR AT ALL METERS" TO ESTABLISH THE UNIFORM RATE OF \$1.00 AN HOUR AT ALL PARKING METERS.

WHEREAS, increasing the hourly rate at all meters in the City of Scranton would result in an increase in revenue to the City; and

WHEREAS, it is in the best interest of the City of Scranton to increase the hourly rate at all meters within the City from \$.50 an hour to \$1.00 an hour.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SCRANTON that the uniform rate at all parking meters is hereby established at \$1.00 per hour and thus File of the Council Number 112, 2003 is hereby amended.

SECTION 1. If any section, clause, provision or portion of this Ordinance shall be held invalid or unconstitutional by any Court of competent jurisdiction such decision shall not affect any other section, clause, provision or portion of this Ordinance so long as it remains legally enforceable minus the invalid portion. The City reserves the right to amend this Ordinance or any portion thereof from time to time as it shall deem advisable in the best interest of the promotion of the purposes and intent of this Ordinance, and the effective administration thereof.

SECTION 2. This Ordinance shall become effective January 1, 2010.

SECTION 3. This Ordinance is enacted by the Council of the City of Scranton under the authority of the Act of Legislature, April 13, 1972, Act No. 62, known as the "Home Rule Charter and Option Plans Law" and any other applicable law arising under the laws of the State of Pennsylvania.
